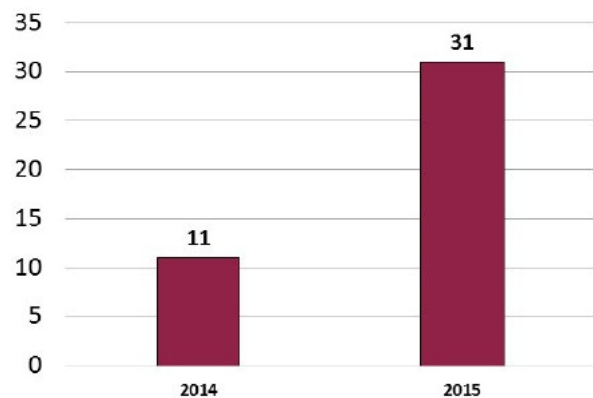
## The French Guineas and the Breeze Up in Deauville
